THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) No, Sir. It was sanctioned in the year 1978-79. Gauge Conversion of Nadia-Kapadvanj section was completed in January, 1993 and new line works between Kapadvanj-Modasa is in progress.

- (b) to (d) There was no reason to investigate. The work has been proceeding slowly/remained frozen due to constraint of resources and relatively lower operational priority of this line.
- (e) and (f) Yes, Sir. The conversion portion of the project from Nadiad to Kapadvanj (45 Kms) has already been compelted.
