Setting-up of Rural Institutes

*500. SHRI RAM RATAN RAM: DR. SHRIKANT RAM-CHANDRA JICHKAR:

Will the Minister of HUMAN RE-SOURCE DEVELOPMENT be pleased to state:

(a) whether Government have decided to set-up Rural Institutes all over the country;

(b) if so, what is the stage at which these proposals are today; and

(c) how much provision has been made for this and by when this will be completed?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (SHRI S.R. BOMMAI): (a) and (b) No, Sir. However, the Government of India has set up a National Council of Rural Institutes (NCRI) to inter alia promote rural higher education on the lines of Mahatma Gandhi's revolutionaryf ideas on education as also to consolidate, network and develop institutions engaged in programmes on Gandhian Basic Education and Nai Talim. The Andhra Pradesh Government is coolaborating with NCRI to develop Swami Ramananda Tirtha Rural Institute at Poehampalli. the Bihar Government has conveyed their willingness to NCRI to set up a similar institute in Bihar. A proposal has also been received from the Assam Government for a rural institute.

(c) The budget for the NCRI for 1996 -97 is Rs. 3.00 crores.

Decentralisation of Education

3177. SHRIMATI BASANTI SARMA: DR. SHRIKANT RAM-CHANDRA JICHKAR; SHRI SURINDER KUMAR SINGLA: Will the Minister of HUMAN RE-SOURCE DEVELOPMENT be pleased to state:

(a) which are the States where Primary and secundary Education is dealt with by the. Zilla Perishad and which are the States where they are not;

(b) whether Government is of the view that Primary and Secondary Education should be directly dealt with by the Panchayati Raj Institutions like the Zilla t'arishad; and

(c) if SQ, what steps are being taken to decentralise education upto the level of the Panchayats?

THE. MINISTER OF STATE IN THE DEPTT. OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) to (c) A committee was constituted in February, 1993 on Decentralised Management of Education to formulate guidelines for the Management of Education at district, sub-district and village levels, keeping in view the 73rd and 74th Constitutional Amendment Acts. The Committee recommended, inter alia, that supervision of primary, upper primary and secondary education to be the responsibility of Standing Committee of Panchayats, Panchayat Samitis and Zilla Parishads respectively. The report of the Committee was endorsed by the CABE in October,- 1993 and subsequently recommended for appropriate adoptation and effective implementation by the States and UTs., primarily responsible for

organisation and management of school education.

Accordingly, several State Governments have initiated steps to decentralise responsibility for education to Panchayat Raj Institutions.

Percentage Share of India's Agricultural Exports

(a) whether in 1995-96 India's agriculture exports made up nearly 16 per cent of total exports;

(c) if so, whether there are hopeful signs now that a diversified agricultural export basket may find the policy less inhibiting;

(d) whether Government's policy is to raise the agricultural exports to 30 per cent of the total exports;

(e) whether any concrete steps have been formulated in this regard; and

(f) if so, the details thereof?
