Section 9 (3) of the Mines and Minerals (Regulation and Development) Act, 1957; the Central Government is empowered to enhance royalty rates on soal not more than once during any period of three years. The next revision, therefore, falls due after 10.10.97.

Resolution by Federation of STC Officers' Association

- *3434. SHRI NAGMANI: Will the Minister of COMMERCE be pleased to state:
- (a) whether it is a fact that Federation of STC Officers, Association passed a resolution in Bombay alleging involvement of Exe. Director (Vigilance) of STC in various loss-making alleged corrupt deals particularly a series of transactions in rice;

- (b) whether it is also a fact that complaints about involvement of a near relative of this E.D. (Vig.) in various rice deals have been alleged; and
- (c) whether E.D. (Vig.) is also involved in the controversial Czech pistol import deal?

THE MINISTER OF STATE OF THE MINISTER OF COMMERCE (SHRI BOLLA BULLI RAMAIAH): (a) STC Officer's Assocation sent a resolution alleging inaction during the last one year by the Vigilance Division of STC. In his fact finding enquiry, the Chairman, STC did not find any substance in these allegations.

- (b) No such complaints have been received.
- (c) The Special Technical Committee of which the present E.D. (Vig.) was the Chief presiding officer submitted an evaluation report to the Government on 17.8.1987 on pistols imported from Czech.
