(iv) non-prforming assets not exceeding 15 per cent of total outstanding loans.

RBI have advised the banks satisfying the above criteria to submit to them a yearly plan duly approved by their Board of Directors for opening branches to enable RBI to advise their concerned Regional offices for issue of licences.

RBI have further reported that during the year 1995-96, they have issued 569 authorisations to public sector banks to open branches in various States/Union Territories.
