According to the Orissa Rehabilitation Policy Act, 1994, a displaced family is being given assistance of Rs. 64,000/- for purchase of house plot, construction of house and purchase of cultivable land. Besides this a rehabilitation assistance of Rs. 500/- per month is given for one year from the date of displacement.

DTC Bus sheds on Noida Road

THE MINISTER OF SURFACE TRANSPORT (SHRI T.G. VENKAT-RAMAN): (a) Yes, Sir.

(b) and (c) Construction of bus sheds is a continuing process depending upon the availability of funds. It has not been possible for D.T.C. to construct bus sheds on all the bus stands due to paucity of funds.

Amnesty International Reports of India

26., SHRI SANJAY DALMIA Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether Government had received any report of Amnesty International pertaining to India; and

(b) if so, the salient features thereof and the reaction of Government thereto?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI I.K. GUJRAL): (a) Yes, Sir.

(b) Amnesty International brings out a report every year on the human rights situation in various countries. The 1995 report includes a section on India which, inter alia, includes a range of general allegations of human rights violations, in Jammu & Kashmir and Punjab. Government of India examines and responds to all Amnesty International reports.

Upgradation of State Highways to National Highways in Andhra Pradesh

(a) whether the State Government of Andhra Pradesh had submitted 9 proposals covering a length of 4,812 k.m. to the Union Ministry vide letter No. 1612 (RIL) (2)/91-3 Dt: 24.2.1992 for upgradation of state highways to National Highways;

(b) if so, whether out of these proposals, Government of India sanctioned state highways from Kurnool to Chittoor to a length of 362 kms as N+18 in January 1993;

(c) the fate of the other proposals;

(d) to what extent the work on the approved highways have been completed; and

(e) by when all proposals are likely to be accepted and work on these is likely to be started?

the Minister of surface transport (shri t.g. venkat- RAMAN): (a) Yes, Sir.

(b) Yes, Sir.

(c) Owing to limited availability of funds for the development of National Highways during the 8th Plan, it has not been possible to accept the proposals.

(d) Improvement of National Highways is a continues process and on N+18, improvement works aggregating to Rs. 7.2 crores have been sanctioned since its declaration and are at various stages of progress.

(e) In view of (c) above, it is difficult to indicate a time frame.
