## Cauvery Water Dispute

6. SHRI H. HANUMANTHAPPA: SHRI JANARDHANA POOJARY:

Will the Minister of WATER RE-SOURCES be pleased to state:

- (a) the latest position of Cauvery Water Dispute; and
- (b) the proposals of the Central Government to solve the problem?

THE MINISTER OF WATER RE-SOURCES (SHRI JANESHWAR MIS-HRA): (a) and (b) To resolve the Cauvery Water Dispute, the Central Government constituted Cauvery Water Disputes Tribunal on 2nd June, 1990. The Tribunal passed an Interim Award on 25.6.91 directing the Karnataka Government to ensure inflows of 205 Thousand million Cubic feet (TMC ft.) of water into Mettur reservoir of Tamil Nadu for each water year (June to May) with monthly and weekly stipulations. Further as per the Interim Award 6 TMC ft. of water for Karaikal region of the Union Territory of Pondicherry will be delivered by
