## Participation of Private Sector in irrigation projects

16. DR. D. VENKATESHWAR RAO: Will the Minister of WATER RESOURCES be pleased to state:

(a) whether Government have not so far invited Private Sector for implementation of irrigation projects in the country;

(b) whether Government have taken any decision to open the same for multinationals to participate therein;

(c) whether number of irrigation projects are pending for want of funds; and

(d) how many offers have come from private sectors to participate in irrigation projects?

THE MINISTER OF WATER RE-SOURCES (SHRI JANESHWAR MISHRA): (a) and (b) For examining

e feasibility and scope of private sector participation in Irrigation and Multi-Pur-pose Projects, the Government constituted a high level Committee which submitted its report on 22nd December, 1995. The Committee concluded that while private sector participation is feasible in respect of all irrigation (surface and ground water) and multi-purpose projects, it would be desirable to introduce this on pilot basis for selected projects. After finalisation of necessary guidelines based on the recommendations of the Committee, the State Governments are to take initiatives in respect of private sector participation in irrigation and multi-purpose projects.

(c) Yes, Sir.

(d) No offer has been received at the Centre from private sectors to participate in irrigation projects.

## **Deployment of Agni and Prithvi Missiles**

17. SHRI JANARDHANA POOJ-ARY: Will the Minister of DEFENCE be pleased to state:

(a) the progress made with regard to the development of Prithvi and Agni missiles so far; and

(b) the time by when these are likely to be deployed?

THE MINISTER OF DEFENCE (SHRI MULAYAM SINGH YADAV): (a) Surfaceto-surface missile PRITHVI has been successfully developed. Re-entry technology demonstrator project 'AGNI' has also been successfully completed. However, AGNI project did not envisage development of a missile system.
