

**Shortage of Potable water in Kailashpuri and Indira Park Colonies**

MALTI SHARMA:

Will the PRIME MINISTER be pleased to state:

(a) whether resident of Kailashpuri and Indira Park colonies in Palam area are facing an acute, shortage of potable water;

(b) whether it is a fact that the Ganga water has been made available upto chhoti pulia (small bridge) in Indira Park, but the water line has not been extended further to the areas of Kailashpuri and Indira Park colonies, if so, what are the reasons therefor; and

(c) what measures government have taken/proposed to take to solve this problem?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN AFFAIRS & EMPLOYMENT (DR. U. VENKATESWARLU): (a) No, Sir. In Kailashpuri and Indira Park colonies water is being supplied through tube wells.

(b) and (c) To improve the supply of filtered water to these areas, a pipe line has already been laid upto Sagarpur (Small bridge). Delhi Water Supply & Sewerage Undertaking has informed that work order for further extension of this pipe line has also been issued and the work is likely to be completed by the end of October, 1996.
