THE MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCE AND PENSIONS (SHRI S.R. BALLASTIBRAMONIYAN): (a) to

(c) The aim of the Government has been to ensure that complete peace and normalcy is restored in the State of Jammu & Kashmir at the earliest. While continuing sustained action to contain the activities of the terrorists and reduce the fear of the gun, a number of other measures and initiatives have also been taken towards the above objective. These include focussed 'action to step up the pace of development and revival of the economic activities and vocations of the people which had been adversely affected by the terrotist violence; efforts to enhance employment opportunities for the youth the in the State, including those who have moved away from the gun; reactivation of the local administration and police and revival of their activities; normal strengthening mechanisms for grievances redressal and enlisting the cooperation of the people with the administration; various confidence building measures, including increased transparency, review of cases of detenues and releases from time to time, and involvement of the people themselves in countering the activities of the militants, etc. Special attention has also been given to encourage the mis-guided youth to give up the gun, and return into the mainstream and the democratic process.

Government has been holding reulgar consultations and dialogue with leaders of various political parties and groups, within the State and at the national level. The Prime Minister has visited all the regions of the State, and other senior Ministers and political leaders have also been visiting the State regularly to interact with the people and to take stock of the situation. The Government has also clearly stated its commitment to maximum autonomy for Jammu & Kashmir, keeping in view the aspirations of the people of all regions of the State, and that further discussions in this regard would be held when an elected Government and Assembly are in position. A number of major Development projects, and Schemes for

rehabilitation of various sectors of the economy which had been most adversely affected by terrorist violence have also been announced.

The measures and initiatives have had a perceptible positive impact on the situation. In the wake of these developments, action to hold Assembly elections has already been initiated, which has drawn visible positive response from the people and various groups in the State. The Government views this as a further important step in the process of restoration of abiding peace and normalcy in the State of Jammu & Kashmir.
