- (c) A number of Voluntary Organisa tions are active in Madhya Pradesh and they are implementing programmes in areas relating to Science & Technology popularisation; Entrepreneurship. de velopment; Acquactuture; sustainable ag riculture; Utilisation of minor forest pro duce; Land and water managment; Bam boo cultivation and value added productmaking; Artisanal leather; Rural potery; Electronics; computer technology etc. It is difficult to precise the exact number of such organisations working in this area becasue of availability of funds for these programmes from various sectoral agen cies and also their own focus shifting from time to time.
