Railway Consultancy Contract in Mauritius

SHRI RAM NATH KOVIND:

Will the Minister of RAILWAYS be pleased to state:

(a) whether the Rail India Techno-Economic Services (RITES) has been awarded a consultancy contract in Mauritius for hydrographic survey and reservoir sedimentation studies for some reservoirs there;

(b) if so, the details thereof with terms of reference;

(c) whether some more foreign contracts are being handled by RITES at present;

(d) if so, the details thereof with terms of reference in each case; and

(e) the earnings made by RITES from such contracts during the last three financial years?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) and (b) RITES has entered into an agreement with Ministry of Energy & Water Resources, Government of Mauritius for carrying out hydrographic survey and sedimentation studies of 4 reservoirs viz. Mare aux Vacoas, La Ferme, La Nicoliere, and Piton du Milieu. Through this study RITES will determine the rate of sedimentation and present useful capacity of the reservoirs and advise the Government of Mauritius on the preventive as well as remedial measures to tackle the sedimentation problem in the reservoirs.
