Reservation of Seats for wards of Delhi University Employees

4028. SHRI V. NARAYANASAMY:
Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether the Delhi University has decided to set apart a quota of seats in different courses for the wards of its employees (both teaching and non-teaching);

(b) if so, the details thereof and whether such candidates will have to satisfy the minimum qualifications for admission;

(c) whether provisions similar to above exist in other Central Universities; and

(d) if so, the details thereof?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) and (b) According to the information furnished by the University of Delhi no separate quota has been set apart for the wards of the University employees in the professional courses, post-graduate courses and the courses where admission is made through entrance test. However, there is a provision for admission of wards of the employees of the University and its colleges against a limited number of seats in under-graduate courses over and above the normal sanctioned strength. Such admissions are subject to fulfilment of the normal minimum eligibility conditions and since the
