

hon. friend's request and I am more worried about my own town, which is on the Grand Trunk Line, Khammam town. The railway line passes through the midst of the town and mercilessly divide the town into two equal halves. There is a gate which remains closed for 18 hours in a day. Sir, I have statistics, gathered from our railway station. There are traffic jams and people try to cross the railway line away from the gate. I would like to know from the hon. Minister whether he is aware of this fact. I would also like to bring to the notice of the hon. Minister that there were about 700 deaths due to accidents during the last ten years.

The second thing is, there are 126 trains passing to and fro and due to this there is a traffic is a traffic jam and that creates a vital problem. Is the hon. Minister aware of the fact that in 1978 itself various representations were received by the Central Government and they were all disregarded, not taken into consideration and now the population has doubled or has increased four times and because of this, traffic jams are taking place, creating problems. The Municipality has recently passed a resolution, a unanimous resolution, asking for construction of an underbridge, not an overbridge—an overbridge is very costly and an underbridge is not that costly. Therefore, I request the hon. Railway Minister to consider the request of the people of Khammam and also of the representatives of various political parties and organisations, for construction of an underbridge.

Introduction of a Course in BBE in Delhi University

\*586. SHRI K.M. KHAN: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether a course in Bachelor of Business Economics (B.B.E.) has since been introduced in some colleges of Delhi University during the current academic session;

(b) if so, the names of such colleges with background and eligibilities fixed for admission;

(c) whether successful candidates after completion of their course will have better scope of employment in Government offices;

(d) whether the course has some other bright future scope; and

(e) if so, the details thereof?

**THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI S. R. BOMMAI):** (a) to (e) A statement is laid on the Table of the Sabha.

#### **Statement**

According to the information furnished by the University of Delhi, the University has introduced, during the current academic year, Bachelor of Business Economics (BBE) in three colleges viz. Ram Lal Anand (Evening) College, Maharaja Agrasen College and Shri Guru Gobind Singh College of Commerce. Candidates securing 55% marks in class XII examination with English as one of the subjects are eligible for admission to the Course. A relaxation of 5% marks is available to candidates belonging to the Scheduled Castes and Tribes.

This degree is equivalent to other under-graduate degrees offered by the University. Candidates passing it will be eligible for all Government jobs where an undergraduate degree is the prescribed qualification. As this course has been introduced only recently, it may be premature to indicate specific job opportunities in the private sector. The course has, however, been introduced with the expectation that there will be significant demand for holders of the degree in the private sector as it provides business orientation to the students. They may also get preference in admission to Master's level courses relating to Business Administration and Commerce.

**SHRI K.M. KHAN:** Mr. Vice-Chairman, Sir, in regard to the course about which I had put the question, there is a lot of demand from other States also, like in Delhi. In this connection, I would like to know from the hon. Minister

whether, if such a request is made by other States, the Government of India would permit starting of such a course and whether they would be encouraged by the Government.

##### **Increase in Forest Cover**

**\*581. SHRI SANJAY DALMIA:** Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

(a) whether the various steps taken in respect of afforestation have increased the forest cover in various States in India; and

(b) if so, the details thereof, State-wise?

**THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (CAPT. JAI NARAYAN PRASAD NISHAD):** (a) According to the State of Forest Report, 1995 the total forest cover of the country as per 1995 assessment in comparison to 1993 assessment has increased in all the States except Andhra Pradesh, Arunachal Pradesh, Assam, Bihar, Himachal Pradesh, Jammu & Kashmir, Madhya Pradesh, Maharashtra, Manipur, Meghalaya, Mizoram, Nagaland, Orissa, Punjab and the Union Territories of Andaman & Nicobar Islands and Dadra and Nagar Haveli. There has not been any change in the forest cover in the States of Goa, Daman and Diu, Kerala and Tripura. In the Union Territories of Lakshadweep and Pondicherry, there is hardly any discernible forest cover.
