THE MINISTER OF STATE OF THE DEPARTMENT OF ANIMAL HUSBANDRY AND DAIRYING IN THE MINISTRY OF AGRICULTURE (SHRI RAGHUVANSH PRASAD SINGH), (a) and (b) According to information furnished by the State Government small commercial poultry farms upto the strength of 2000 poultry birds have closed down due to high cost of poultry feed ingredients and lack of marketing facilities.

- (c) This Department has not received any specific request for the improvement of poultry farms. Some representations were received about putting restrictions on export of maize etc.

Construction of Railway Over Bridges

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) to (d) Railways consider replacement by Road Over/Under bridges of busy level crossings having a traffic density of 1 lakh or more TVUs (Train Vehicle Units, a figure obtained by multiplying the number of trains by the number of road vehicle units passing over the level crossing in 24 hours). Proposals of such
