Newsreport on urea packaging deal scandal

Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

(a) whether Government's attention has been drawn to a news-item published in the Financial Express dated the 26th August, 1996, captioned "NFL bags 10 crore loss in packing deal scandal";

(b) whether it is a fact that the National Fertilizers Ltd. (NFL) procured sub-standard plastic and jute bags for urea packaging worth Rs.50 crores; and

(c) if so, what are the details/reasons for NFL's contravention of standardized bidding procedures and purchase orders and whether any inquiry has been made against this fraudulent transaction by NFL officials?

THE MINISTER OF STATE OF THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI SHEES RAM OLA): (a) Yes, Sir.

(b) and (c) Based on a preliminary inquiry conducted by National Fertilizers Ltd., it is observed that there is a *prima-facie* case of irregularity in the matter of purchase of bagging material by the Bhatinda unit of National Fertilizers Ltd. It has accordingly been decided to entrust the case to the Central Bureau of Investigation for detailed investigation. In the meantime, four officers involved in the matter have been placed under suspension.

Appointment of Bonafide Students in DMS Milk Booths

(a) whether the Delhi Milk Scheme appoints bonafide students to market

milk through its booths in different parts of Delhi;

(b) if so, the details of the formalities to be completed by desiring students;

(c) whether the appointed students are also given some designation, salary and have some fixed working hours; and

(d) if so, the details thereof?

THE MINISTER OF STATE OF THE DEPARTMENT OF ANIMAL HUSBANDRY AND DAIRYING IN THE MINISTRY OF AGRICULTURE SHRI RAGHUVANSH PRASAD SINGH): (a) to (d) Students who are matric and above are appointed Senior Depot Agents and Depot Agents in DMS booths. The minimum age of Senior Depot Agent is 18 and of Depot Agent 16. They work for 1 1/2 hours in a shift and are paid a commission of Rs. 8/- and Rs. 6/- respectively per shift. A cash security of Rs. 1500 is taken from Senior depot agents by deducting from the Commission due to them in instalments.

THE MINISTER OF AGRICULTURE (SHRIU CHATURANAN MISHRA): (a) The Aggregate Measurement of Support (AMS) in respect of major 17 crops including wheat and rice, calculated for the reference period of 1986—89 for the purpose of Uruguay Round of GATT negotiations may kindly be seen in the statement (see below).

(b) The Aggregate Measurement of Support was calculated for the reference period of 1986—89 only, as required under the GATT.
