

Introduction of Direct Train from Nagpur to Jaipur

4008. MISS SAROJ KHAPARDE: Will the Minister of RAILWAYS be pleased to state:

(a) whether it is a fact that the people of Vidarbha region of Maharashtra are demanding a direct train from Nagpur to Jaipur for quite a long period;

(b) if so, the details thereof;

(c) the details of the action taken so far by the Railways in this regard; and

(d) by when the train is likely to be flagged off; if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) and (b) Representations have been received including from Shri Rajender Khungar, President, Bhartiya Janata Party, Nagpur for introduction of a train between Nagpur and Jaipur.

(c) and (d) For the convenience of Jaipur-Nagpur Passengers, a weekly train between Madras and Jaipur via Nagpur is being introduced from October 96 Time Table.

(a) whether it is a fact that his Ministry has some quota for admission in Kendriya Vidyalayas which is unaffected even after judicial intervention;

(c) whether it is a fact that this quota has recently been introduced while Ministers and M.Ps. have been denied their due; and

(d) if so, the justification therefor?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) to (d) As per decision taken by the Board of Governors of Kendriya Vidyalaya Sangathan 100 seats are provided to children of the employees of Ministry of Human Resource Development from August, 1990 and 25 seats for children of the employees of Ministry of External Affairs/Research & Analysis Wing from July 1989. No other quota has been introduced recently.
