Need to introduce job-linked vocational courses

- (a) whether there is a great need to introduce job-linked vocational courses;
- (b) if so, the States where such courses have been introduced; and
- (c) the emphasis laid by the Central Government for funding the State Governments to set-up institutions for imparting, training and education for job-linked courses?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY **HUMAN** RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) to (c) Under the Centrally Sponsored Scheme of Vocationalisation of Secondary Education launched in February, 1988, vocation courses have been introduced at the higher secondary level in selected schools. All State/UTs except Lakshadweep have joined the vocational education programme for which substantial financial assistance is provided by the Central Government.

Backlog of reserved scats in Railways

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) and (b) As per Department of Personnel & Training's directives, a Special Recruitment Drive was launched during the year 1995 to wipe out the shortfall of vacancies reserved for SC/STs existing on 1.4.95 through direct recruitment. The shrotfall identified in the Special Recruitment Drive launched on 1.4.95 vis-a-vis the shortfall cleared by 16.7.96 and balance of vacancies is detailed below:

The balance of 24 vacancies could not be filled up due to non-availability of SCySTs with requisite qualifications in technical categories viz. Pharmacists. Staff Nurse, Stenographers, Radiographers, etc.

Monitoring of Water quality of Godavari river

Rajahmundry in Andhra Pradesh is being monitored;

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (CAPT. JAI NARYAN PRASAD NISHAD): (a) and (b) The water quality of river godavari is being monitored every month at upstream and downstream of Rajahmundry by the Andhra Pradesh Pollution Control Board under the Monitoring of Indian National Aquatic Resources Programme of the Central Pollution Control Board. The Bio-chemical Oxygen Demand (BOD) of the river at downstream of Rajahumundry is 2.0 miligrams per litre to 4.0 miligrams per litre against the prescribed standard of a maximum of 3 miligrams per litre required for outdoor bathing.

(c) and (d) No proposal for setting up a continuous monitoring station in this regard has been received from the State Government.

Setting up of Mahila Ayog in States

BOMMAI): (a) to (c) Assam, Delhi, Kerala, Maharashtra, Orissa, Punjab, Tamil Nadu, Tripura and West Bengal have set up Commissions for Women at their own initiative and not under the direction of the National Commission for Women. Others have also been advised to do so.

Demand for Divisional Office at Badarpur
