# Rising prices of pulses and other Foodgrains in PDS

199. SHRI RAMDAS AGARWAL: Will the Minister of CIVIL SUPPLIES, CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION be pleased to state:

- (a) whether Government are aware of he rising trend in prices of pulses and ther food grains available in open narket as well as at the P.D.S. shops in nany parts of the country;
- (b) whether Government have undertaken any survey to find out the reasons for price-rise during 1996 as compared to 1995 year as well as comprehensive scheme to improve P.D.S. in the country; and
- (c) what measures Government have taken so far to bring down the prices of food grains as well as of pulses at a reasonable level particularly in desert/

hilly areas of States like Rajasthan and Orissa?

THE MINISTER OF FOOD AND MINISTER OF CIVIL SUPPLIES. CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI DEVENDRA PRASAD YADAV): (a) to (c) The Ministry of Civil Supplies, Consumer Affairs and Public Distribution has been monitoring on daily, basis the retail prices of 12 essential commodities namely, rice, wheat gram, arhar, groundnut oil, mustard oil, vanaspati, sugar, tea, salt, onions and potatoes at 18 selected centres. On the basis of the available statistics, a marginal variation has been observed in the prices of only a few items due to onset of their lean supply season, gap between the demand and their supply in the country, transportation bottlenecks due to heavy rains and floods and rise in the cost of their inputs. With a view to keeping the prices of essential commodities under check, the Public Distribution System is being strengthened to provide foodgrains at cheaper rates to the poor strata of the society. Besides, stringent actions are being taken against the speculators, hoarders and traders indulging in unfair trade practices. The essential commodities are also being supplied through Cooperatives Stores, Mobile Stores, Kendriya Bhandar etc. at reasonable prices. Essential Commodities like pulses and edible oils are being imported in desired quantities to augment their supplies in the domestic market.

## कल्याण मंत्री (श्री बलवंत सिंह रामूवालिया): (क) अनुसूचित जाति/अनुसूचित जनजाति के लिए होस्टलों/आश्रम स्कूलों की अनुरक्षण लागत का खर्च संबंधित राज्य सरकार द्वारा वहन किया जाता है। भारत सरकार होस्टलों/आश्रम स्कूलों भवनों के निर्माण के लिए ही राज्य को अनुदान देती है।
