Inclusion of socio-environmental elements in WTO Agenda

196. SHRIMATI VEENA VERMA: will the Minister of COMMERCE be pleased to state:

- (a) what steps have been taken by Government so far in the light of former Prime Minister's concern expressed by him at the last ESCAP summit that developing countries should not allow the developed countries to induct the Socio-Environmental elements in the agenda or objectives of the World Trade Organisation, and not to allow any such elements to be inducted even with thinly veiled intentions, to nullify the comparative advantage that the developing countries enjoy under any such pretext or pretensions; and
- (b) what steps have been taken by Government to bring about a firm consensus on this stand of the Prime Minister, amongst the Developing Nations and with what success so far?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI BOLLA BULLI RAMAIAH): (a) and (b) The then Prime Minister in his __!

address to the 50th Session of ESCAP in April 5, 1994 had stated that while developing countries and developed countries alike must share action to deal with genuine social and environmental concerns, we shall not countenance any moves to put these concerns on the trade agenda with the thinly veiled intention to nullify the comparative advantage of developing countries.

alongwith India, other interested countries, have successfully opposed moves by some countries to put social concerns on the trade agenda. The WTO is presently discussing the relationship between trade and environment in the Committee on Trade and Environment where India is an active participant. The discussions are at an early stage and do not envisage restrictions on trade in order to achieve environmental objectives.

Abuse of traditional drugs substances in rural areas of Madhya Pradesh

198. SHRI SURESH PACHOURI: Will the Minister of WELFARE be pleased to state:

- (a) whether Government are aware that in the rural areas of Madhya Pradesh there is widespread abuse of traditional drugs substances like opium and cannabis:
- (b) if so, the action taken by to educate people particularly the rural yourth about drug abuse and its harmful effects on them with details;
- (c) wheher any help of voluntary organisations of the state is also being

taken to tackle the drug abuse in raral parts of the State; and

(d) if so, the details thereof?

THE MINISTER OF WELFARE (SHRI BALWANT SINGH RAMOOWALIA): (a) No specific date is available with regard to the abuse of traditional drugs like opium and cannabis in the rural areas of Madhya Pradesh.

- (b) Drama based audio programme of ten minutes duration Drug Abuse Prevention and Prohibition are being produced in Hindi and boradeast over Bhopal and Indore AIR Stations in a Weekly radio Sponsored Programme entitiled 'Aao haath Badhayen' of the Ministry, at least one in a month throughout the year.
- 42 hoardings on durg abuse prevention are on continuous display at 21 districts in M.P.—(Kankar, Jagdalpur, Dantewara, Kawarda, Korba, Raipur, Bilaspur, Mahasumund, Durg, Raigarh, Dhantari, Senoi, Narsinghpur, Bataghat, Rajnandgaon, Janjgir, Chaindwara, Mandala, Ambikapur, Mahendragrab, Shahadol).

Awareness material such as Posters, Handbills, Booklets, Bookmarkers and comics on Drug Abuse Prevention and Prohibition in Hindi are despatched from time to time to State Welfare Secretaries. Feild Exhibition Officers, Field Publicity Officers and NGOs for further dissementation. Grants are also given to voluntary Organisations for awareness building programmes.
