ORAL ANSWERS TO QUESTIONS Target fixed for arrival of Tourists

*81. SHRIMATI JAYANTI PATNAIK: Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state:

- (a) the tourist arrival target fixed for the years 1993-94, 1994-95 and 1995-96 in the country in general and for the eastern state in particular;
- (b) the actual achievements made in the country in the above three years (year-wise and state-wise); and
- (c) the programme drawn up by Government with regard to development of infrastructure in order to increase the visits of tourists into the country?

THE MINISTER OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF TOURISM (SHRI SRIKANTA JENA): (a) to (c) A Statement is laid on the table of the Sabha.

Statement

(a) and (b) The targets and achievements of international tourist arrivals for the year 1993-94, 1994-95 and 1995-96 are as given below:—

Central Department of Tourism does not fix any targets for the States/Union Territories.

(c) The development of tourism infrastructure is a continuous process and is achieved by providing financial assistance to State/Union Territory Governments

and by providing the necessary support facilities and incentives to private sector. Assistance to State/UT Governments are provided under different schemes on the basis of specific proposals received from them. The schemes include construction of tourist complexes/tourist lodges, wayside amenities, motels/cafeterias/restaurants, tourist reception centres, provision of mini buses and jeeps for wild life viewing, cruise boats and ferry launchers for water transport. In order to assist the private entrepreneurs, the Department of Tourism has set up an "Investment Facilitation Cell" apart from providing incentives like interest subsidy, tax exemption, etc.

JAYANTI PATNAIK: SHRIMATI Sir. India, including the eastern sector with its forests and natural attractions and continuous history spread over several centuries has unbeatable credentials as a tourist destination. As replied to the question by the Minister, the target fixed for a year is sometimes being achieved and sometimes it is not being achieved. As for the State-wise targets, the Minister has said that the Central Government does not fix any target for the States. Sir. India accounts for 0.4 per cent of the world's tourist arrival. Sir, when the tourist arrival during the year 1994-95 has crossed two million mark, the increase was very negligible. In order to exploit the tourist potential especially in the eastern sector, I would like to know from the hon. Minister whether creation of special tourism area is a strategy to indestination-tourism the whether any area has been selected in the Eastern States for this purpose. If so, what steps have been taken to expedite this project and by when will it be completed? Sir, as it would be the finest centre. I would like to know whether the Government of India will extend all help for this project?

SHRI H. HANUMANTHAPPA: Sir, yesterday you clubbed Question Nos. 61 and 62 ... (Interruptions)... Sir, I would like to suggest that Question No. 86 may also be clubbed with this Question. ...

(Interruptions)... That question also relates to development of tourism projects. ... (Interruptions)...

MR. CHAIRMAN: I think it should be a separate question because Karnataka is unique. ... (Interruptions)...

SHRI V. NARAYANASAMY: It relates to Karnataka only. ...(Interruptions)...

SHRI SRIKANTA JENA: Sir, for the year 1993-94, the target was two million and the achievement was 1.8 million. For the year 1994-95, ...(Interruptions)...

SHRIMATI JAYANTI PATNAIK: Sir, all these figures are already given in the statement. ...(Interruptions)... I am asking about separate tourism areas ...(Interruptions)...

SHRI V. NARAYANASAMY: You can have some understanding on the subject. ... (Interruptions)...

SHRI SRIKANTA JENA: As for special tourism areas, we have a national strategy for tourism development. The strategy paper was circulated among various States, and also among various sectors and departments for their opinion. This strategy paper is still under the consideration of the State Governments. We are waiting for their comments. ... (Interruptions)... I will also be happy to circulate the national strategy paper on tourism development and after getting responses from different State Governments, we will ... (Interruptions)...

SHRI V. NARAYANASAMY: Sir, he should be specific ... (Interruptions)...

SHRI SRIKANTA JENA: Sir, I am coming to the specific point. ... (Interruptions)... Recently the Director General of Tourism visited the STA in Orissa, Puri, Konark and Bhubaneshwar and had long discussions with the tourism department of Orissa Government and they have formulated certain plans and they are yet to get a final set.

SHRIMATI JAYANATI PATNAIK: I would like to know when it will be completed.

SHRI SRIKNATA JENA: I will need your cooperation.

SHRIMATI JAYANATI PATNAIK: We are very earger to know. The Central Govennment should extend all help.

SHRI SRIKNATA JENA: The Central Government will cooperate. (Interruptions)

SHRIMATI JAYANTI PATNAIK: The site has already been decided between Dayanadi and Harachandi.

SHRI SRIKANTA JENA: There are certain problems, environmental problems.

SHRIMATI JAYANTI PATNAIK: That site was already rejected and another site was selected between Dayanadi and Harachandi.

SHRI SRIKANTA JENA: Exactly, I am coming to that. About 3500 acres of land is to be acquired by the State Government and a special authority in the special cell has to be opened by the State Government. The moment the State Government is ready, we are also ready.

SHRIMATI JAYANTI PATNAIK: Is there any programme to bring chartered flights from foreign countries to eastern areas to increase tourist arrival? If so, what are the details thereof?

SHRI SRIKANTA JENA: The Ministry of Civil Aviation and Tourism has been bifurcated recently.

SHRIMATI JAYANTI PATNAIK: But your Ministry should pursue this matter.

SHRI SRIKANTA JENA: The Minsitry of Tourism is, in fact, pursuing and we will consistently pursue this aspect so that I get the right kind of cooperation from the Civil Aviation Ministry so that more tourists come to India.

SHRIMATI JAYANTI PATNAIK: But we are worried about the arrival of tourists. So it is your job to pursue it.

SHRI SRIKNTA JENA: I fully agree with you that the Tourism Ministry should take the initiative and take the

initiative in a proper direction so that the Civil Aviation Ministry responds positively.

SHRI NILOTPAL BASU: Mr. Chairman Sir, I think along with Orissa, West Bengal also is a part of the eastern sector. So I would be raising some specific questions about how in this entire strategy for tourism development in the eastern sector, West Bengal can also be clubbed. Here the question relates to the special tourism area with regard to Puri, Bhubaneshwar and Konark. I would like to know whether it will be extended to include the Sunderbans and the Darjeeling Hills as well in the entire master plan.

My (b) part of the supplementary is, we are seeing that there is an increase in the scope of tourists coming from Eastern Asia and Japan and even China. For that, the tourists who are coming to Nepal can be brought to this part of the country by opening an international airport or international facility in the Bagdogra airport. Will the Government consider actively and pursue having such an international airport at Bagdogra?

I am given to understand that the West Bengal Government is proceeding to develop a master plan on forest tourism in the Dooars area. In what way can the State be helped in conducting a study for developing that master plan and subsequently participating in the project?

SHRI SRIKANTA JENA: Sir, recently the Tourism Minister of West Bengal met me and we had initial discussions and the West Bengal Government are preparing a master plan, not only connecting Konark and Puri with Sunderbans and again connecting the entire circuit of Darjeeling but they are also preparing a master plan on Sunderbans. They have not yet finalised the master plan but I hope the West Bengal Government's tourism department will soon send the master plan so that we can get a view of that.

Sir, the hon. Member is quite right. If Konark, Puri and the coastline up to Sunderbans is connected up to Darjeeling, it can be a good circuit. There can be a Special Tourism Authority and tourism can be developed in that sector. The only thing is the problem of communication, i.e., the rail and the air communication. Bagdogra Airport is under the control of the Defence Minsitry and if it is opened for tourist purposes, I hope, it will be a good proposition in the sense that a number of tourists, Japanese tourists and Chinese tourists, can come.

SHRI NILOTPAL BASU: Now that cirumstances have totally changed, I would like to know whether the Tourism Ministry will take it up with the Defence Ministry to have the defence clearance.

SHRI SRIKANTA JENA: After having discussions with the Prime Minister, I have already taken note of this. I will take it up with the Defence Minsitry and others concerned.

श्री महेश्वर सिंह: सभापित महोदय, यह बात सर्वविदित है कि हिमाचल प्रदेश का मनाली उत्तर भारत का एक सबसे मशहूर पर्यटक स्थल है और वह देश के बाकी भागों के साथ राष्ट्रीय मार्ग 21 से जुड़ा हुआ है। गत वर्ष भारी वर्षा के कारण कुल्लू और मनाली के बीच दस किलोमीटर सड़क बह गई थी जिसके कारण खदेशी और विदेशी पर्यटकों की संख्या में निश्चित रूप से कमी आई है तो मैं मंत्री महोदय से जानना चाहूंगा कि क्या वह भूतल मंत्री से बात करके उस सड़क की मरम्मत के लिए अधिक से अधिक धन हिमाचल प्रदेश की सरकार को उपलब्ध करवायेंगे, जिससे सड़क ठीक हो सके?

श्रीमती कमला सिन्हाः सभापित महोदय, मैं आपके माध्यम से सरकार से यह जानना चाहूंगी कि सरकार ने अभी मूल प्रश्न के उत्तर में उड़िसा के आसपास के कुछ इलाकों के विकास के बारे में चर्चा की है। महोदय, आप जानते हैं कि भगवान बुद्ध को बुद्धत्व बोधगया में प्राप्त हुआ था। बोधगया न केवल भारत का बल्कि सारी दुनिया का प्रसिद्ध स्थान है। सारी दुनिया के बुद्धिष्ट वहां आते हैं और साथ ही यह हिन्दुओं का भी बढ़ा तीर्थ-स्थल है। मरने के बाद वर्ष में एक बार कोई न कोई हिन्दु जाता ही है वहां। और हिन्दू भी वहां पर जाकर अपने पुरखों को तर्पण देते हैं। चाहे वह मारीशस का रहने वाला हो, चाहे अमरीका का रहने वाला हो या कनाडा का रहने वाला हो या कनाडा का रहने वाला हो या कराडा का रहने वाला हो सभी वहां पर आते हैं।

महोदय, मैं जानना चाहती हूं कि क्या मंत्री महोदय बिहार के टूरिज्म डवल्पमेंट विकास के लिए राजगीर के विकास के लिए क्योंकि आज से ढाई हजार साल पहले पहली बुद्धिष्ट संसद वहां हुई थी और बोधगया, राजगीर और वैशाली में जहां भगवान बुद्ध हमेशा जाया करते थे, को बढ़ावा देना चाहती है? आपने आम्रपाली का नाम सुना होगा और पढ़ा भी होगा, आम्रपाली वहां की थी। दुनिया में सर्वप्रथम गणतंत्र नगर बुद्धिष्ट नगर था, तो क्या सरकार वैशाली बोधगया, राजगीर को बुद्धिष्ट सर्किट के साथ जोडकर विकास का काम करेंगी?

मेरे प्रश्न का दूसरा हिस्सा यह है कि क्या सारनाथ और श्रावस्ती आपस में बौद्धिष्ट सर्किट में आयेगा, जो कि भगवान बुद्ध के जीवन के साथ जुड़ा हुआ है? स्मरनाथ में भगवान बुद्ध ने पहला प्रवचन किया था और साथ ही साथ गंगटोक और सिकिम को भी इसमें जोड़ना चाहिए तो में इसका मंत्री महोदय से जवाब चाहती हं।

SHRI SRIKANTA JENA: Sir, Buddhist circuit is major tourist attraction for India, particularly, for chinese tourists. They prefere to go to these places. Sir, for the Buddhist circuit development in Bihar and Uttar Pradesh including Bodh Gaya, Vaishali and Saranath a sum of Rs. 284 crores was sanctioned for the project and the project will be completed by 1997.

I hope both the Bihar and the Uttar Pradesh Governments will take care of this. After this project is completed, after getting the infrastructure ready, I hope we can get Buddhist tourists from abroad.

श्रीमती कमला सिन्हाः सभापति जी, सिक्किम के बारे में कोई जवाब नहीं आया। विश्व प्रसिद्ध गोम्पा, पूरा सिक्किम बौद्धिष्ठ स्टेट है, उसके बारे में आपने कोई चर्चा नहीं की।

SHRI SRIKANTA JENA: Sir, as far as Sikkim is concerned, the whole State is a place of tourist attraction not only for the Buddhist tourists; it is a place of tourist attraction for other tourists as well.

Again, Sir, the problem is one of communication—air link. Unless we get the Bagdogra Airport opened for the tourists, it is very difficult to link Sikkim. In this connection, the Chief Minister of Sikkim met me recently. He had proposed that, at least, the Bagdogra Airport should be opened for tourists so that

the tourists can go up to Sikkim. (Interruptions)

MR. CHAIRMAN: I am giving chance to a new Member who had not put any question before. Shri Prem Chand Gupta.

SHRI PREM CHAND GUPTA: Mr. Chairman, Sir, most of my points have been covered by Shrimati Kamla Sinha. however, since I am rising for the first time, I would like to say something about the tourism problem in Bihar, Sir, I know that lack of infrastructure is causing a major setback to tourism in the eastern sector of the country. But Sir, it is the dream of every Buddhist to visit the holiest place of his religion, namely, Bodh Gaya; and of every Jain, Raigir. Therefore, I would request the hon. Minister to explore the possibility of operating chartered flights from places like Singapore, Bangkok, Hong Kong and Taiwan. Apart from this, if these places are well connected by Indian Airlines' flights, I am sure tourism would grow. This, in turn, would contribute to the development of the local area and also earn us precious foreign exchange.

SHRI SRIKANTA JENA: Sir, I fully agree with the hon. Member's suggestion. I was just having a look at the figures. I find that China got 43 million tourists last year, whereas, the arrivals in India were only two million. What we are lacking is in the kind of infrastructure that is required so that more number of tourists could come to India. In addition to infrastructure, all the monuments have to be maintained properly: they have to be decorated and maintained properly.

We need to do many things. That is why Sir, a Strategy Paper has been circulated. I hope the hon. Finance Minister would agree with me. The tourism sector is the third largest foreign-exchange-India. We earned earner for Rs. 9,500 crores of foreign exchange through tourism last year. Therefore, it has to be given more emphasis. Infrastructure is one of the areas in regard to which the differnt Ministries and all the State Governments have to play a major role. When the Strategy Paper is finalised, I hope many things can be sorted out.

Vulgarity in Indian Cinema

*82 SHRI PARMESHWAR KUMAR AGARWALLA: Will the Minister of INFORMATION AND BROADCAST-ING be pleased to state:

- (a) whether Government are aware of increasing vulgarity in the Indian Cinema particularly in dancing gestures and using double meaning words in the songs;
- (b) if so, whether any assessment has been made of its adverse impact on our young generation and findings thereof;
 - (c) if not, the reasons therefor; and
- (d) what measures have been contemplated to check this trend?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRI C.M. IBRAHIM): (a) to (d) A statement is laid on the Table of the House.

Statement

- (a) Complaints/press reports about increase in vulgar scenes in films are received by Government from time to time.
- (b) and (c) It has been decided recently to entrust a study on "Sex and violence in films and its impact on society" to the Indian Institute of Mass Communication.
- (d) In accordance with the provisions of the Cinematograph Act, 1952, all films are exhibited only after clearance by the Central Board of Film Certification. The Board, while certifying films, inter alia, ensures that the medium of films remains responsible and sensitive to the values and standards of society without unduly curbing artistic expression and creative freedom.

SHRI PARMESHWAR KUMAR AGARWALLA: Mr. Chairman, Sir, the bureaucratic reply which has been given reminds me of an old proverb: 'Nero was fiddling when Rome was burning'. Sir, the fact of life is, parents all over the country are warried about the future of their children—college-going and even

school-going children. Newspaper are full of such heinous crimes as teenaged girls being raped by older people, murder and other crimes. In this connection, (a) part of my first supplementary is whether the Government is aware of the judgement of the hon. Supreme Court, delivered by hon. Judges Mr. Justice Jaichandra Reddy and Mr. Justice G.N. Ray, in which they have observed as follows—I quote...

MR. CHAIRMAN: Ask the question.

SHRI PARMESHWAR KUMAR AGARWALLA: But this is the relevant part of the observation—very important—in this regard.

MR. CHAIRMAN: You summarize it and ask the question.

SHRI TRILOKI NATH CHATUR-VEDI: The Minister cannot reply since he does not know about the judgement.

MR. CHAIRMAN: He will reply.

SHRI PARMESHWAR KUMAR AGARWALLA: In that case...

MR. CHAIRMAN: Summarize it.

SHRI PARMESHWAR KUMAR AGARWALLA: It is only a few lines, Sir. If you please permit me, I will read it

MR. CHAIRMAN: All right.

PARMESHWAR SHRI KUMAR AGARWALLA: "Whether it is compulsory that a heroine should invariably appear on the screen with accentuated angularities, depend depressions and exaggerated protuberances of body"? This is just the first paragraph. Now, in view of this observation of the hon. Supreme Court, I would like to know whether any action has been taken by the Government. This is part (a) of my first supplementary. Part (b) of my first supplementary is whether the Government is aware that financing of the film industry is mostly being done by smugglers and mafia, from within the country and outside, to destory the basic fibre of our society under a long-term strategy? If so, what action does the Government propose to take in this regard to save the society and the younger generation?
