

(ख) से (घ) सेबी ने सूचित किया है कि भारतीय औद्योगिक विकास बैंक ने 26 फरवरी, 1996 को 500 करोड़ रुपए मूल्य के आरक्षित प्रतिदेय बांड के सार्वजनिक निर्गम की घोषणा की, जिसमें 500 करोड़ रुपए की अतिरिक्त राशि के प्रतिधारण का विकल्प भी था जो कि विकास वित्त संस्थाओं के लिए सेबी के दिशानिर्देशों के अन्तर्गत अनुमत है। निर्गम को कुल 1511.40 करोड़ रुपए का अभिदान प्राप्त हुआ। भारतीय औद्योगिक विकास बैंक ने निर्गम में प्राप्त अतिरिक्त अभिदान के प्रतिधारण के लिए सेबी को आवेदन किया था। सेबी ने आग्रह स्वीकार नहीं किया। तदन्तर, भारतीय औद्योगिक विकास बैंक ने असफल आवंटियों को अतिरिक्त अभिदान वापस करते हुए उसी आवेदन में बांडों के निजी स्थापन का एक अलग प्रस्ताव किया। सेबी ने स्पष्ट किया है कि सेबी के तरजीही आवंटन संबंधी दिशानिर्देशों का उल्लंघन नहीं हुआ है। जब कभी भी इसके अधिनियम, विनियम एवं दिशानिर्देशों का उल्लंघन होगा, सेबी निरन्तर कारवाई करता रहेगा।

**Increase in Tax Compliance and Collection**

324. DR. D. VENKATESHWAR RAO: Will the Minister of FINANCE be pleased to state:

(a) whether the tax compliance in the country has gone up by 21% and the collection of both direct and indirect taxes upto Rs. 33,000 crores;

(b) if so, whether inspite of this increase the tax default is still higher;

(c) if so, in which category i.e., industrialists businessmen, film actors, bureaucrats and politicians are the highest defaulters in the tax evasion; and

(d) what further steps are being taken to increase the tax collection?

THE MINISTER OF FINANCE AND THE MINISTER OF COMPANY AFFAIRS (SHRI P. CHIDAMBARAM):

(a) to (d) The Information is being collected and will be laid on the Table of the House.

**Linking of Tourist Spots in Gujarat by Air or Rail**

325. SHRI RAJUBHAI A PARMAR: Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state:

(a) the details of tourist spots in Gujarat especially in Saurashtra-Kutch region which are not yet linked by air or rail; and

(b) the steps taken or being taken by Government to link these places by air or rail?

THE MINISTER OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF TOURISM (SHRI SRIKANTA JENA): (a) There are several tourist spots identified by the State Government in Gujarat including Saurashtra-Kutch region. However, tourist spots which are presently airlinked are Ahmedabad, Bhavnagar, Bhuj, Jamnagar, Kandla, Keshod, Porbandar, Rajkot and Vadodra.

Modhera, where a Sun Temple is situated is not having rail link but is connected by road and is served by Mehsana rail head. However, Dwarka, Porbandar, Veraval, Junagarh, Chorwad, Palitana, Kosad, DIU & Sasangir are major tourist centres in Saurashtra/Kutch region of Gujarat State and are linked by rail and road.

(b) The linkage of tourist places by air depends upon the commercial viability. Similarly, linkage of tourist places by rail is based on the availability of resources and inter se priority as also specific requests from the State Governments.

**Enrolment of Government servants as advocate**
