Human Rights Commission in Geneva in 1996

- (b) At this Session a statement from Pakistan contained several references to Kashmir, *inter alia* questioning the validity of the elections in Jammu and Kashmir and the independence of the National Human Rights Commission of India. India exercised the right of reply to expose the false propaganda contained in the statement from Pakistan.
- (c) The countries attending the 52nd Session of the UN Commission on Human Rights understood India's position on the matter.

## Fencing of borders to check infiltration from neighbouring countries

- 382. DR. D. VENKATESHWAR RAO: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether the Border Security Force has started fencing and flood lighting on the North-East borders to check the infiltration from Bangladesh and May-anmar;
- (b) if so, by what time is the work on fencing likely to be completed;
- (c) to what extent infiltration has been checked:
- (d) whether the border with Pakistan in all sectors has been fenced; and
- (e) to what extent has fencing also helped in reducing the infiltration from Pakistan?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI MOHD. MAQBOOL DAR): (a) to (c) Babed wire fencing along different sectors of Indo-Bangladesh border is being carried out by the Border Roads Organisation, Central Public Works Department and Assam Public Works Department. There is no provision for fencing on Indo-Myanmar border or flood-lighting of any border in the North-East.

The fencing work on 896 kms. of Indo-Bangladesh border is scheduled to be completed by March, 1998.

Only a part of the border in the NE States has been fenced. However, it is felt that fenced sectors can be guarded more effectively to check infiltration.

(d) and (e) The progress of fencing work along the Indo-Pak border is as under:—

As stated earlier, it is felt that fenced sectors can be guarded more effectively to check infiltration.

# Augmentation of strength of police personnel in the Capital

- 383. SHRI V. NARAYANASAMY: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether Government are aware that there is deterioration in law and order situation in the Capital in the recent months involving deaths of elderly people; and
- (b) if so, the steps taken to bring the culprits to book and remedial measures taken to augment the strength of the police personnel in the Capital?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI MOHD. MAQBOOL DAR): (a) and (b) Eight cases of murder of elderly people have been reported in Delhi during the current year (from 1.1.96 to 30.6.96) while nineteen such cases were preported during the corresponding period in 1995.

All the cases registered are properly investigated so as to bring the culprits to book. Steps taken to prevent crimes against elderly people include, inter alia, the following:—

 (i) A Senior Citizens' Security Scheme is in vogue under which senior citizens are identified, beat-wise and division-wise, in every police

station. Beat Staff of the Police Stations visits these senior citizens to offer them advice on security measures that should be taken by them and to reassure them.

- (ii) During beat and division patrolling, special vigil is maintained around the residences of senior citizens.
- (iii) The antecedents of servants and others working with old persons are varified.
- (iv) The Chowkidars of the area have been briefed to keep an eye on the residences of this category of persons.

#### **Countries supporting India for Security Council Seat**

385. SHRI RAMDAS AGARWAL: Will the Minister of EXTERNAL AF FAIRS be pleased to state:

- (a) which are the countries who support India for the Asian seat in the United Nations Security Council;
- (b) whether the Sri Lankan Foreign Minister including diplomats of other countries who met the India's Exteral Affairs Minister recently have shown any interest in this regard; and
- (c) what steps Government have taken so far at the diplomtic level and through other channels to elicit support of other countries for India in this matter?

MINISTER OF EXTERNAL AFFAIRS (SHRI I.K. GUJRAL): (a) to (c) India's candidature to the non-permanent seat on the United Nations Security Council, for the term 1997-98 has received an encouraging response. The Government of India have taken several steps to apprise other governments of our candidature. These measures include approaches in various capitals and to diplomatic missions in New Delhi, presence in regional summit meetings and interaction through special envoys to foreign capitals and visitors to New Delhi. The Permanent Mission of India to the United Nation! fo .also cerentinuously engaged in this effort, as required.
