(b) to (d) At this stage there are no specific complaints or evidence before the Government to warrant such an inquiry.

Un-awnned railway crosaings in Gujarat

(c) It has been decided that no new unmanned level crossing will be added and the sensitive unmanned level crossings will be, on a planned basis, after due prioritisation, converted into manned level crossings with the help of the State Govts, who have to invest the initial capital cost.

Safety meausres in Railways

626. SHRI GHUFRAN AZAM: SHRI KRISHNA KUMAR BIRLA:

Will the Minister of RAILWAYS be pleased to state:

(a) whether proper safety meausres are not being implemented in Railways, causing accidents;

(b) if so, whether the officers have recently admitted that most of the accidents occur due to human error; and

(c) if so, whether Railway Staff has been held responsible for most after accidents that occurred during the past three months?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) No, Sir. Proper safety measures are being implemented.

(b) and (c) Causewise analysis of accidents reveals that human error has been one of the major causes of accidents. Each accident case is enquired into, responsibility is fixed and action is taken.
