Will the Minister of AGRICULTURE be pleased to state:

(a) whether-wide-spread devastations were caused by cyclones and heavy torrential rains in the coastal areas of Maharashtra, Tamil Nadu, Andhra Pradesh, Gujarat, Kerala and other States in June this year;

(b) if so, the estimated loss of life and property and other devastations caused thereby; and

(c) the details of the assistance given by Government to the affected States for relief and rehabilitation of victims?

THE MINISTER OF AGRICULTURE (SHRI CHATURANAN MISHRA): (a) and (b) According to the reports received from the State Govt., cyclones and accompanying heavy rains in June 1996 resulted in floods in varying degrees in parts of Andhra Pradesh, Gujarat, Karnataka, Kerala, Maharashtra, and Tamil Nadu causing loss of 333 human lives and damage to 1.26 lakhs houses and other Private & Public Property.

(c) Government of India have released 2 installments of central share of Calamity Relief Fund for 1996-97 to all the affected States for undertaking relief measures. The funds released are as follows:

Special Livestock Breeding Programme

604. SHRI SANJAY DALMIA: Will the Minister of ANIMAL HUSBANDRY AND DAIRING be pleased to state:

(a) the amount granted to Uttar Pradesh for the Centrally sponsored Special Livestock Breeding Programme during the Eighth Five Year Plan; and

(b) the amount sanctioned during the Seventh Plan and the amount spent during the above period for implementation of three Centrally sponsored programmes viz. the poultry, the sheep and the piggery development in U.P?

THE MINISTER OF STATE OF THE DEPARTMENT OF ANIMAL HUSBANDRY AND DAIRYING IN THE MINISTRY OF AGRICULTURE (DR. RAGHUVANSH PRASAD SINGH): (a) In the 8th Five Year Plan, Rs. 32.82 lakhs were allotted to Uttar Pradesh during 1992-93. Thereafter on the recommendations of the National Development Council the programme was transferred to the State Sector.

(b) The amount granted and spent in the 7th Five Year Plan in UP under the Centrally Sponsored Scheme 'Special Livestock Development Programme' is as under:—

विषय कपास की पैदावार

605. श्री रामजीलाल: क्या कृषि मंत्री यह बताने की कृपा करेंगे कि:

(क) इस वर्ष देश में कपास की कितनी पैदावार हुई तथा पिछले तीन वर्षों की तुलना में यह कितनी ज्यादा है;

(ख) सरकार द्वारा किसानों के हितों की रक्षा करने हेतु ऐसी कोई कार्यवाही न किये जाने के क्या कारण हैं जिसमें उन्हें इस संबंध में मंदी का सामना न करना पड़ता;

(ग) क्या इसे देखते हुए सरकार कपास का निर्यात करेगी; और

(घ) तत्संबंधी ब्यौरा क्या है?

कृषि मंत्री (श्री चतुरानन मिश्र): (क) 1995-96 मौसम के लिए कपास के उत्पादन का अनुमान 130.3 लाख गांठे (प्रत्येक 170 कि.ग्रा. की) रखा गया है जो 1992-93, 1993-94 और 1994-95 मौसम के उत्पादन से क्रमशः 16.3 लाख गांठे, 22.9 लाख गांठे और 9.2 लाख गांठे अधिक है।

(ख) सरकार ने कपास उत्पादकों के हितों की रक्षा के लिए कई कदम उठाए हैं। इनमें कच्चे कपास के लिए न्यूनतम समर्थन मूल्यों की घोषणा, मिलों तथा ओटई और प्रेसिंग फैक्ट्रियों के लिए भण्डारण सीमा में छूट चयनित ऋण नियंत्रण में छूट और कच्चे कपास तथा सूत के लिए अधिक निर्यात कोटे का जारी किया जाना शामिल है।

(ग) तथा (घ) इस वर्ष सरकार ने 1995-96 मौसम के दौरान निर्यात के लिए कपास की 13.65 लाख गांठे जारी की हैं।

Demands for Rickshaw Pullers in South Central Railways

As a matter of policy, no such shelters are provided to Rickshaw Pullers and hence there is no proposal to provide this facility.
