- (c) and (d) About 2000 ha. has been brough under shrimp farming in the coastal areas o Maharashtra. Shrimp farming is taken up it the private sector by farmers for whom the following assistance has been made avilable:
- i) establishment of Brackishwater Fisl Farmers Development Agencies in the District: of Thane, Raigad, Ratnagiri, Sindhudurg which provide a package of technical, financial and extension supprt to shrimp farmers
- ii) provision of incentives in the form o: subsidy for development of shrimp farms, botl for extensive and semi-intensive culture shrimp/prawn hatcheries for supply of seed establishment of shrimp feed mills, training of shrimp farmers and establishment of demonstration-cum-training centres, etc.
- iii) land lease policy for leasing Govenment brackishwater land to private entrepreneurs to take up prawn farming activities.
