## Super Highways in Madhya Pradesh

- (a) whether it is a fact that the Prime Minister has announced a scheme for construction of Super Highways in the country;
- (b) if so, the length of the proposed highways that would run through Madhya Pradesh;
- (c) the progress made so far in implementing the scheme in the State; and
  - (d) by when it would be completed in the State?

THE MINISTER OF STATE OF THE MINISTRY OF ROAD TRANSPORT AND HIGHWAYS [MAJ. GEN. (RETD.) B.C. KHANDURI]: (a) and (b) Hon'ble Prime Minister has announced the National Highway Development Project (NHDP) which is for 4-laning of Golden Quadrilateral and North-South-East-West Corridors in a total length of 13252

- km. A length of 652 km. in the State of Madhya Pradesh is proposed under North-South-East-West Corridors.
- (c) A length of 10 km. in the Agro-Gwalior section of National Highway-3 is under implementation and another 33 km. in the same section will be taken up during 2001-2002.
- (d) Work on all the projects on North-South and East-West Corridors passing through Madhya Pradesh is targeted to be completed by December, 2007.
