(c) Whenever considered necessary and feasible, the equipment is trial evaluated, as part of its technical evaluation, after both technical and commercial bids have been obtained. Commercial bids of only those vendors are opened, who meet the technical requirements. After opening the commercial bids, a comparative statement of prices is prepared and commercial negotiations held with the lowest bidder.

(d) and (e) The Government continuously endeavours to effect improvements in the structures, processes and procedures related to Procurement. The Group of Ministers (GoM) constituted on 17th April, 2000 by the Government has recommended a series of measures, including the creation of a separate and dedicated institutional structure *i.e.* the Defence Procurement Board, to undertake the entire gamut of procurement related functions in a more professional, coordinated and cost effective manner. The recommendations of the GoM have been presented to the Prime Minister on 26.2.2001. After examination and acceptance of the Report by the Government, action as required will be taken expeditiously.

Talks with Myanmar on Cooperation in Hydro-carbon Sector

(b) whether New Delhi is sending any high-level expert-delegation to Myanmar shortly to explore the possibilities in this regard, as reported in the 'Hindustan Times' dated 18th February, 2001;

(c) if so, the likely gas pipeline routes from Myanmar linking to India; and

(d) the details of the availability of crude oil/natural gas from the proven fields?
