Double Laning of NH-53

1131. SHRI W. ANGOU SINGH: Will the Minister of SURFACE TRANSPORT be pleased to state:

(a) whether Government are aware of the fact that NH-39 frequently affected by landslides and other disturbances in Assam/Nagaland; and

(b) whether there is any plan to develop the NH-53 upto the standard of double-lane National Highway?

THE MINISTER OF SURFACE TRANSPORT (SHRI T. G. VENKATRAMAN): (a) NH-39 is being maintained in traffic worthy condition within the available resources, and the disturbances due to landslides etc., are being tackled expeditiously by the executive agencies.
