THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND **FORESTS** (CAPT. JAI NARAIN PRASAD NISHAD): (a) and (b) Government has taken appropriate action against the polluters as per the existing rules and regulations pertaining environment. Central and State Pollution Control Boards and pollution control committees in the Union Territories periodically monitor pollution levels and take necessary action against the defaulters. A number, of cases against the industries are pending in courts including the Supreme Court.

(c) and (d) The order regarding shifting of polluting units has been passed by the Supreme Court recently. While ordering shifting of units, the Court has put necessary conditions including safeguarding the interests of labourers.

## Hurdles in the completion of Konkan Railway Project

- (a) by when the Konkan Railway Project is likely to be completed;
- (b) what are the main hurdles leading to delay in completion of the project; and
- (c) whether Government have accepted the recommendation of the Committee of M.P.'s on Konkan Railways, if so, action taken so far regarding the implementation of the recommendations?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) The Konkan Railway Project is likely to be completed within the current financial year.

- (b) The main reasons for delay in completion of the projects are.
  - (i) Shortage of funds.
  - (ii) The slow progress of tunnels in softsoil in Goa area due to unforeseen geological problems.
  - (iii) Due to rehabilitation of 500 m of high embankment in Cortalim area of Goa sector, which had failed and required extensive remedial measures.
- (c) The Government has accepted the recommendations of the Committee of MPs on Konkan Railways. Konkan Railway Corporation has been asked to implement the same as far as possible at this stage.
