(ii) पुस्तकों तथा अन्य उपयोगी वस्तुओं के रूप में सहायता देने के लिए कॉलेजों में विद्यार्थी सहायता निधि तैयार करना; (iii) अनुसूचित जाति / अनुसूचित जनजाति विद्यार्थियों को छात्रवृत्ति प्रदान करने की योजना के अंतर्गत सरकार द्वारा शुल्क की प्रतिपूर्ति करना (iv) बस का निशुल्क पास तथा (v) पात्र मामलों में कॉलेजों द्वारा कुछ शुल्कों को माफ करना।

## Survey of New Railway lines in Orissa

1447. SHRIMATI JAYANTI PAT-NAIK: Will the Minister of RAILWAYS be pleased to state:

(a) whether the survey has been completed for the construction of some new railway lines in Orissa;

(b) if so, the lines for which survey has been completed so far;

(c) whether Government have selected some of those proposed lines for construction during 1996-97;

(d) if so, the details of the survey report received and the recommendations made by Traffic-Cum-Engineering Survey team on the implementation of those lines; and

(e) the action initiated thereon?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) Yes, Sir.

(b) Haridaspur-Paradeep new line.

(c) to (e) Yes, Sir. This work has been included in the budget, 96-97.

## **Educational Upliftment of Muslims**

1448. MAULANA OBAIDULLAH KHAN AZMI: Will the Minister of HU-MAN RESOURCE DEVELOPMENT be pleased to state the steps being taken by Government for the educational upliftment of the Muslims?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RE-SOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): The National Policy on Education, 1986 as updated in 1992 and its Programme of Action recognise Muslims as educationally backward minorities. The Programme of Action was tabled in the House on 19th August, 1992. There are programmes for upliftment of educationally backward minorities such as Area Intensive Prog-Backward ramme for Educationally Minorities, Modernisation of Madarsa Community Education, Polytechnics, Coaching classes for Educationally Backward Minorities and Training of Minority educational insititution personnel.

## Provision of Basic Amenities to Settlers on Railway Land in Mumbai

1449. SHRI RAJ BABBAR: Will the Minister of Railways be please to state:

(a) what action Government are taking to provide basic amenities to the lakhs of people settled for more than fifty years on railway land in Mumbai;

(b) what is the reason for not agreeing to the basic demand for electricity and water; and

(c) by when Government will settle this issue?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) to (c) Settling/rehabilitating the slum dwellers, who are unauthorisedly occupying Railway land, is not the responsibility of the Railways. Therefore, the matter of providing basic civic amenities to these encroachers by railway does not arise.
