provide assistance for insitu moisture conservation, treatment of areas on inputs for crop demonstrations and production, and propagate use of suitable varieties of crops and agronomic practices. The objective of these scheme is to augument crop productivity and production as per targets fixed for the plan. However, there is no proposal at present for launching a second green revolution as such.

Extension of Tickets for on going Journeys

1397. SHRI YERRA NARAYANASWAMY: Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that Railways have stopped extending tickets for on going journeys through the Travelling Train Conductors;
