supplies foodgrains to States/UTs for issue through fair price shops at Central Issue Prices (CIP) which are subsidised. In RPDS areas the CIP is further subsidised and is Rs. 50 per quintal less than CIP for normal PDS areas, States/UTs have also been advised to add not more than 25 paise per kg. over and above CIP while fixing the end retail prices in RPDS arcas. The States/UTs are free to further subsidise the prices on their own while fixing the end retail prices for fair price shops. Tamil Nadu, Karnataka, Orissa, Gujarat, Maharashtra extend further subsidy from their own funds. The Central Government does not give additional subsidy for such schemes of States/UTs.
