Anomalies in duty structure

- 2215. SHRI SATISH AGARWAL: Will the Minister of INDUSTRY be pleased to state:
- (a) whether Government's attention has been drawn to the newsitem appearing in the Business Standard of 4th June, 1996, under the caption "Industry wants anomalies in duly structure removed"; and
- (b) if so, what action is proposed to be taken in the matter?

THE MINISTER OF INDUSTRY (SHRI MURASOLI MARAN): (a) Yes, Sir.

(b) In the Union Budget, 1996-97, the Govt. have reduced the basic custom duty on a number of raw material such as

chemicals, plastics, metals, textile fibres and yarns, mineral substances, raw materials and components for electronic industry etc. These changes are expected to reduce the cost of inputs for the domestic industry. In a number of cases, a graded duty structure has been provided for with a lower rate for raw materials, a middle rate for components and parts and higher rate for finished products. Thus, the anomalies in the duty structure have been reduced to a considerable extent.

Setting up of Steel Plant at Bonai in Orissa

2216. SHRI MAURICE KUJUR: Will the Minister of STEEL be pleased to state:

- (a) whether any decision has been taken for setting up steel plant at Bonai in Orissa;
 - (b) if so, the details thereof; and
 - (c) if not, the reasons therefor?

THE MINISTER OF STEEL AND MINISTER OF MINES (SHRI BIRENDRA PRASAD BAISHYA): (a) No, Sir.

- (b) Does not arise in view of (a) above.
- (c) The Union Government, at present, have no proposal to set up any new greenfield steel plant at Bonai. According to the new Industrial Policy, Iron and Steel Sector has dereserved and delicensed subject only to certain locational restrictions. Thus, private companies/entrepreneurs are free to set up iron and steel plants anywhere in India. However, as intimated by the State Government of Orissa, there is no proposal for setting up of a steel plant at Bonai in Orissa.
