- (f) whether such a cut of date is in force in respect of the pension schemes of Air India Employees, Delhi Transport Corporation etc.; and
- (g) whether Government propose to take steps to rectify this anomaly against bank employees retired prior to 1st January, 1986?

THE MINISTER OF FINANCE (SHRI P. CHIDAMBARAM) (a) and (b) In pursuance of an understanding reached between Indian Banks' Association (representing Banks' Management) and representatives of bank employees/officers in October 1993, a pension scheme has been introduced in lieu of contributory provident fund (broadly on the basis of pension scheme applicable to Government? Reserve Bank of India employees) in the public sector banks (Except State Bank of India which already had a pension scheme).

In terms of the scheme, employees who were in service of the bank before 29.9.95 and continue to be in service on 29.9.95 had the option either to opt for pension in lieu of contributory provident fund scheme or continue with the contributory provident fund scheme. Employees who joined the bank service on or after 29.9.95 are governed by the pension regulations only. Employees who retired on or after 1.1.1986 are also eligible for pension provided they give their option and apply for the sceheme within prescribed period and refund the bank's contribution towards provident fund alongwith interest received with further simple interest @ 6% p.a. from the date of withdrawal of the provident fund till the date of refund.

- (c), (d) & (g) The employees of aforesaid public sector banks who retired prior to 1.1.1986 are not entitled for the pension but they have already availed the benefit of contributory provident fund. The pension scheme in these banks is on the lines of the scheme of Reserve Bank of India which also stipulates the cut off date as 1.1.1986. It may be mentioned that when introducing any new benefit, stipulating a cut-off date is inevitable. Further it is neither feasible nor practicable to cover all past retired employees.
- (e) Indian Banks' Association on has reported that it does not collect such information.

(f) The information is being collected and will be laid on the Table of the House.
