

Unbudgeted Spending

Will the Minister of Finance be pleased to state:

- (a) the cumulative figure for unbudgeted spending as on 1st July, 1996;
- (b) what are the reasons for this; and
- (c) what steps are proposed to be taken to control unbudgeted spending?

THE MINISTER OF FINANCE AND MINISTER OF COMPANY AFFAIRS (SHRI P. CHIDAMBARAM): (a) Every item of expenditure of the Government is required to be covered by sanctioned provision in the Grant for a year. Any incidence of expenditure exceeding the sanctioned provision in a Grant is known only at the year-end after the Appropriation Accounts for the year become available. The position in this regard prevailing at any mid-year point (like, July 1) is, however, not available as monthly accounts cannot throw up this information.

(b) Does not arise.

(c) All Governmental expenditure are incurred with the sanction of competent authority. The sanctioning authority has to ensure availability of sanctioned provisions in the Grant before authorising the expenditure. Where it is likely to be exceeded or any new item of expenditure comes up during the year, necessary provisions are made through Supplementary Demands for Grants.

Proposal for new airports in Karnataka

(d) whether new airstrip will be constructed in Bijapur?

THE MINISTER OF CIVIL AVIATION (SHRI CM. IBRAHIM): (a) Airports Authority of India has no plans to construct any new airport in Karnataka.

(b) 50 seater aircraft is operating to Hubli. Development of Hassan, Mysore and Bellary airports will depend on the traffic potential and economic viability.

(c) No, Sir.

(d) 'No objection' of the Government of India has been issued to the Government of Karnataka for construction of a new airport at Bijapur on Build-own-Transfer/Build-own-Operate basis.
