#### Shutting down of Goods Shed at Howrah

2557. SHRI ASHOK MITRA: Will the Minister of RAILWAYS be pleased to state:

(a) whether a decision has been taken to shut down the railway goods shed located at Howrah;

(b) if so, whether the implications of such a decision for trade and transactions in the eastern and north-eastern sectors of the country have been taken into consideration; and

(c) whether Government will be agreeable to refer the issue for examination to corinee of experts before implementing decision?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) to (c) Howrah goods shed is operational and has not been closed. The goods shed is situated immediately after the Howrah coaching station at the southern end. Remodelling and expansion of Howrah Coaching Sta- ' tion -is due now to deal with future growth and pattern of suburban and non-suburban passenger Services. The mod- alities for this purpose were examined by two expert committees and the plan for remodelling and expansion of the coaching station has been finalised. Further, a task force with representatives from the Planning Commission, West Bengal Govt., Calcutta Development Metropolitan Authority, Calcutta Port Trust, Calcutta Corporation, Eastern, South Eastern and Metro Railways had also submitted report in 1983 recommending development of additional coaching facilities by shifting Howrah goods. The Railway Reforms Committee (RRC) had also re commended shitting of Howrah goods shed in their report in 1983. Hence nomination of another expert Committee on this issue does not seem necessary.

With the need for dealing with the ever increasing coaching traffic, there would be a need to shift the Howrah goods shed in the due course. Dankuni, which is at a distance of about 15 kms from Howrah goods shed, is already dealing with bulk traffic and closure of the goods shed at Howrah is not likely to have any adverse implications on the trade and commercial transactions with any part of the country.

(b) and (c) The Vice-Chancellor, Visva-Bharati, has constituted a fact-finding Committee to investigate the status of objects of Art in Kala-Bhawana vis-a-vis the process of accession to the same and to suggest, inter alia, ways and means for upkeep and maintenance of the objects of Art in Kala-Bhawana.
