

(b) the number of wagons placed with the Railways under the above scheme;

(c) the stage at which the matter stands at present as regards the supply of wagons for which orders have been placed by the Railways; and

(d) the steps taken by Government to utilise the wagon manufacturing capacity of the units both in the private and public sectors in West Bengal, which are clamouring for orders being placed with them for manufacture and supply of wagons?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) and (b) Orders for 4214 wagons (10535 four wheelers) have been placed by the parties under this scheme. 1801 wagons (4503 four wheelers) have already been manufactured and supplied under this scheme upto 30.6.96.

(c) and (d) For 1996-97, 25,000 four wheelers units of wagons are planned to be procured against Railways' Rolling Stock Programme. In addition to this, orders have been placed for 3605 four wheelers wagons under 'Own Your Wagon Scheme'. As on 1.4.1996, orders for 14715 four wheelers were outstanding on wagon builders. Out of these, 10197.5 four wheelers were outstanding on wagon builders located in West Bengal. Further orders against tender are under finalisation against which West Bengal units will also get their share.

#### External borrowing for Unigauge Project

2573. SHRI ISH DUTT YADAV: Will the Minister of RAILWAY be pleased to state:

(a) whether Government are seeking loans from World Bank and Asian Development Bank for its unigauge project;

(b) if so, the details thereof; and

(c) the reaction of external funding agencies thereto?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) No, Sir.

(क) और (ख) आठवीं पंचवर्षीय योजना के वर्षों के दौरान केन्द्र और राज्यों/संघ राज्य क्षेत्रों द्वारा शिक्षा पर किया गया बजटीय व्यय सकल राष्ट्रीय उत्पाद का 3.5% रहा है।

(a) whether it is fact that though Government/the Board of Governors of Kendriya Vidyalaya Sangathan had decided to accord representation to employees' associations of KVS and its Board of Governors in 1991 and the same was given effect to in that year, the same has not been continued after 1994; and

(b) if so, the reasons therefor?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) Yes, Sir.

(b) The Kendriya Vidyalayas Sangathan has reported that the rules of the Sangathan do not provide for representation of the employees on the Board of Governors.

**Dumping of Toxic Wastes by Swedish Companies**

(a) whether it is a fact that the Swedish Companies are being investigated for allegedly dumping toxic industrial wastes in India;

(b) if so, how many companies are involved and what steps are being taken by Government to stop this nuisance;

(c) whether it is a fact that the Swedish authorities refused to identify the companies involved; and

(d) if so, the reasons therefor and what is being done by Government in this regard?

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (CAPT. JAI NARAYAN PRASAD NISHAD): (a) No, Sir.

**Survey regarding Primary Schools**

2577. SHRI G. PRATHAPA REDDY: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether Government have conducted any country-wise survey to find out the number of rural and backward areas where there are no primary schools and the distance the children of the areas have to cover for attending the school;

(b) whether Government propose to provide schools in those areas on priority basis;

(c) if so, the details thereof;

(d) whether Government propose to provide some aid to the families living below the poverty line for spread of education in such areas; and

(e) if so, the details thereof?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) Yes, Sir. All India Educational Surveys are conducted periodically by States under the aegis of National Council of Educational Research and Training (NCERT) to assess the availability of existing schooling facilities at different stages of education. The 6th All India Survey, which has been conducted recently, has ascertained the number of rural habitations without primary schools and the distance-wise availability of primary schools.

(b) and (c) According to available information, 94% of the country's rural population has access to a primary school within one km. of walking distance. The responsibility for establishing primary schools in the unserved and under-served areas lies with the respective State Government which have evolved their own norms for this purpose in accordance with broad national guidelines.

(d) There is no such proposal under consideration of the Ministry.

(e) Does not arise.
