## Flood affected rail lines in Gujarat

2587. SHRI AHMED PATEL: Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that in the recent past some railway tracks passing through the tribal areas in the State of Gujarat were washed away by flood waters;
  - (b) if so, the details thereof;
- (c) whether it is also a fact that these railway lines have not been restored causing difficulties to the inhabitants of these areas in the State:
  - (d) if so, the reasons therefor; and
- (e) by when Government propose to restore these railway lines?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) & (b) Yes, Sir. The sections are

- i) Chhotaudepur-Bodelli
- ii) Ankleshwar-Rajpipla
- iii) Jhagadiya-Netrang
- iv) Kosamba-Umarpada
- (c) to (e) Yes, Sir. The lines have not been restored, but these sections have adequate road connections to serve the needs of the inhabitants of the area. Restoration of the sections would involve heavy cost which would be uneconomical in view of the meagre traffic.

## Rail coach factory in Orissa

to Ouestions

2588. SHRI MAURICE KUJUR: Will the Minister of RAILWAYS be pleased to state:

- (a) whether Government propose to set up a rail coach factory in Orissa, particularly in its tribal areas;
- (b) if so, by when it is likely to be set up; and
  - (c) if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) to (c) No. Sir. There are two coach manufacturing units with Indian Railways., one at Madras and one at Kapurthala. Each factory can manufacture about 1000 coaches per year. In addition, there are two factories in the Public Sector that are capable of manufacturing coaches.

With the available coach manufacturing capacity ia. the country, there is-, no justification to set up another- coach manufacturing unit.
