## Release of Relief Fund

- 2615. SHRIMATI RENUKA CHOWDHURY: Will the Minister of AGRICULTURE be pleased to state:
- (a) whether the fund sanctioned by the National Relief Committee for heavy rains and floods in October, 1995, have not yet been released;
  - (b) if so, the reasons therefor; and
- (c) the steps taken for ealry release of the fund?

THE MINISTER OF AGRICULTURE (SHRI CHATURANAN MISH-RA): (a) Funds aggregating Rs. 104.00 crores approved by the National Calamity Relief Committee as assistance from the National Fund for Calamity Relief to the six States of Andhra Pradesh, Arunachal Pradesh, Bihar, Meghalaya, Rajasthan and West Bengal in the wake of floods of September-October, 1995 have been released on 23rd August, 1996.

## Poor performance by Delhi Students in CBSE Examination

2616. SHRI RAJNATH SINGH: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether it is a fact that the students of Government and Govern ment-aided schools in Delhi performed very poorly in the Class 10th and 12th examinations in 1996;
  - (b) if so, the reasons therefor; and
- (c) what steps will be taken to improve the performance of such students in future?

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RESOUCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) Yes, Sir.

(b) The Government of National Capital Territory of Delhi have intimated the majority of the students admitted to Govt, and Govt aided schools come from very poor socio-economic background and very high percentage of them are first generation learners. This primarily contributes to poor results.

(c) The Govt of National Capital Territory of Delhi have stated that an action plan has been initiated with the involvement of the district heads and all education officers, and involving those principles who have shown good performance over the years. Under this special classes for bridging the gaps and

also strengthening the basics of the students coupled with examination-oriented education is being taken up from this year.
