2653. SHRI SANJAY DALMIA: SHRI ISH DUTT YADAV:

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether the Mahila Samriddhi Yojana is not being implemented fully in cities; and
- (b) if so, the details thereof and the reasons therefor and the steps being taken by Government to implement this scheme in the cities?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI S.R. BOMMAI): (a) No, Sir.

(b) The scheme of MSY was conceived for the empowerment of rural women, hence the same was not launched in urban areas. During 1995-96 Planning Commission was requested to extend the scheme in urban areas, however it was indicated by Planning Commission thatany modification could be undertaken only after the Programme Evaluation Organisation's Report.

Import of peritoneal dialysis solution

(a) whether it is a fact that Baxter, a foreign-based Company has been

importing Pertioneal Dialysis solution in P.V.C. bags without any payment of customs duty;

- (b) whether Government are aware that some Indian Companies are also manufacturing the same solution in the country;
- (c) whether such Indian companies are importing raw material for manufacturing PVC bags by paying 80% customs duty; and
- (d) if so, what are the reasons for the anomaly?

THE MINISTER OF STATE OF THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI SHEES RAM OLA): (a) Yes Sir. Peritoneal Dialysis solution is exempted from payment of custom duty on the recommendation of Ministry of Health.

- (b) Yes Sir. As per available information, there is the same that mainly M/s. Core Healthcare Ltd., licenced by the Government of Gujarat for manufacture of this item i.e. Peritoneal Dialysis solution.
 - (c) and (d) In accordance with

notification No. 46/96-CUS, dated, the 23rd July, 1996, the raw material namely Polyethylene and Co-polymer of Ethylene having specific gravity of less than 0.94 are allowed to be imported at concessional rate of 30% basic duty.
