#### Grants given by Ford Foundation

2612. SHRI VEDPRAKASH P. GOYAL: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether the Ford Foundation gives grants to Indian Cultural institutions/organisations/trusts and societies etc.;

(b) if so, the names of such bodies, the amount given to each and the purpose of grants given during the last five years; and

(c) the criteria for selection of such beneficiaries?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI S.R. BOMMAI): (a) to (c) The Ford Foundation extends grant assistance mainly to Non-Governmental Organisations, research institutions, Government agencies and universities in areas of agriculture and rural development, health and population, planning and management, education and culture etc. Individual grants are also extended by the Foundation for training. Requests for grant assistance are processed and decided by the Foundation in accordance with its own procedure. One of the criteria for selection is that the proposal for assistance should be innovative and should meet the Foundation's Programme interests. Before extending the grant assistance, the Foundation obtains clearance from Department of Economic Affairs, Ministry of Finance. A Statement indicating grant assistance in areas of Education and culture approved by the Ford Foundation to various Indian organisations in the US Fiscal years 1991,

1992, 1993, 1994 & 1995 alongwith purpose of each grant as reported by Ford Foundation's New Delhi Office is at Annexure. [See Appendix 178 Annexure No. 60]

#### Medical facilities in Railway Junctions and Express trains

(d) The centrally protected monuments are inspected periodically by officers of Circles/Branches/Headquarter and maintenance and conservation of these monuments are carried out as per their actual need depending on the archaeological norms.
