

motivate farmers to adopt improved pulses production technology incentives are being provided for seeds, improved farm implements, sprinkler irrigation sets, Dal processors, storage, bins, micronutrients, *Rhizobium* culture, etc. Besides these, field demonstrations and farmers' training in improved pulses production technology are also being organised, under the on-going centrally sponsored "National Pulses Development Project" (NPDP). No new incentives are being contemplated to be provided to the farmers, as yet under the NPDP during the VIII Plan.

However, introduction of trains on Indian Railways is a continuous process subject to operational feasibility, resource availability and traffic justification.
