Subsidy given to Fertilizer Manufacturers

- (b) whether any claims for subsidy are still outstanding; and

THE MINISTER OF STATE OF THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI SHEES RAM OLA): (a) The amounts disbursed under the Retention Price-cum-Subsidy Scheme (RPS) for controlled fertilizers and the scheme of special concession for decontrolled fertilizers were Rs. 4300 crore and Rs. 500 crore, respectively.

- (b) and (c) Claims of Rs. 4537 crore were received during 1995-96 for payment! under the RPS. During the same period, claims of Rs. 620 crore were received for I payment under the scheme of special concession for decontrolled fertilizers.
- I Claims of about Rs. 6 crore under the RPS are yet to be settled for want of further information/clarification.

- (b) in the news item it is alleged that on 19th July, 1996 the Delhi Milk Scheme accepted 13, 970 litres of milk containing additives from a union of Bikaner.
- (c) The news report is not correct. The milk supplied by the Rajasthan Coopera-I tive Dairy Federation (Bikaner.UnitJ on | 19th July, 1996 was subjected to all pre-; scribed tests and it was found to be free from any additives and was hence accepted.
