(a) whether the University Grants Commission has been sanctioning grants every year to V.V. Inter College and V.V. Post-Graduate Colleges, Shamli, Muzaffarnagar;

(b) if so, the details thereof, year-wise, from 1992-93 to 1995-96;

(c) whether the V.V. Post-Graduate College is not affiliated to Merrut University;

(d) if so, the reasons for sanctioning grants;

(e) whether the original name of V.V. Post-Graduate College was Vaish Inter and Post Graduate College;

(f) whether adoption of the changed name has been prohibited by directives of some authority; and

(g) if so, the reasons for changing the original name of the college?

Appeal to farmers regarding use of Fertilizers

2645. SHRI K.M. KHAN: Will the Minister of AGRICULTURE be pleased to state:

(a) whether Government while enhancing fertilizers subsidy in the recent past has appealed to the farmers through media to give their land the best mix of fertilizers to maintain long-term health and productivity of the soil;

(b) if so, the details thereof;

(c) whether Government propose to take some measures to achieve the motto of the appeal; and

(d) if so, the details thereof and if not, the reasons therefor?

THE MINISTER OF AGRICULTURE (SHRI CHATURANAN MISHRA): (a) and (b) Yes, Sir. An appeal was made to the farmers through the newspaper to take advantage of massive fertilizer subsidy and give their land the best mix of fertilizers to maintain long-term health and productivity of soil. The farmers were asked:

(1) To get phosphatic and potassic fertilizers at reasonable rates;

(2) To facilitate application of soil nutrients in a balanced manner;

(3) To help in improving soil health;

(4) To help better crop production and productivity.

(c) and (d) Detailed guidelines were issued to the State Governments and Union Territory Administrations to negotiate and arrive at prices most advantageous to the farmers and to take
