THE MINISTER OF TEXTILES (SHRI R.L. JALAPPA): (a) Yes, Sir. IJIRA Calcutta has developed such technology (hydrocarbon free jute bags) and it has export potential.

(b) and (c) IJIRA interacts with the industry for such promotional activities utilising internal resources.

#### Sick Textile Mills in Punjab

1699. SHRI IQBAL SINGH: Will the Minister of TEXTILES be pleased to state:

(a) whether it is a fact that a number of textile mills are sick in the State of Punjab;

(b) if so, the details thereof; and

(c) the steps taken by Government in this regard?

THE MINISTER OF TEXTILES (SHRI R.L. JALAPPA): (a) AND (b) As on 31.5.96, 6 mills in Punjab were registered with BIFR as sick namely: 1. Khanna Silk Mills 2 Punjab Spg & Wvg. Mills Ltd. 3. Punjab Spg. & Wvg. Mills 4. JCT Fibres Ltd. 5. Punjab State Hosiery & Knitwear Dev. 6. Shri Lalit Fabrics (P) Ltd.

(c) Government has set up Board for Industrial and Financial Reconstruction (BIFR) to enquire into the working of sick industrial companies and to prepare and sanction, as appropriate, schemes for their revival.

#### सड़क विकास की योजना

(ख) क्या सन् 2001 तक राष्ट्रीय राजमार्गों की दोहरीकृत सड़कों की लम्बाई 45,530 कि०मी० और सिंगल लेन मार्गों की लम्बाई 18,500 कि०मी० करने का प्रस्ताव है; और

(ग) आठवीं पंचवर्षीय योजना के दौरान मध्य प्रदेश में कितनी आंतरिक लम्बाई की सड़कों को राष्ट्रीय राजमार्ग घोषित किया जाना प्रस्तावित है और इसके लिये कितने किलोमीटर लम्बी सड़क स्वीकृत की गई है?

जल-भूतल परिवहन मंत्री (श्री टी. जी. वेंकटरामन): (क) यह मंत्रालय मुख्यतः राष्ट्रीय राजमार्गों के विकास के लिए उत्तरदायी है। अन्य सभी सड़कें संबंधित राज्य सरकारों के कार्य क्षेत्र के अंतर्गत आती हैं। जहाँ तक राष्ट्रीय राजमार्गों का संबंध है, उनका विकास एक सतत् प्रक्रिया है और सुधार कार्य विभिन्न पंचवर्षीय/वार्षिक योजनाओं के जरिए किए जाते हैं।

(ख) इस समय ऐसा कोई प्रस्ताव नहीं है।

(b) the action Government have taken thereon; and

(c) the number of persons arrested/prosecuted and the nature of action taken against them?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI MOHD. MAQBOOL DAR): (a) to (c) Information is being collected and will be laid on the Table of the House.

#### **Sinking of Water-Level**

1703. SHRI BHUPINDER SINGH MANN: Will the Minister of WATER RESOURCES be pleased to state:

(a) the details of States where water-level is sinking every year and the reasons therefor;

(b) whether the water-level in Punjab is also going down; if so, to what extent; and

(c) the steps being taken to improve the water-level in these States especially in Punjab?

THE MINISTER OF WATER RESOURCES (SHRI JANESHWAR MISHRA):

(a) As per long term observations, decline in the levels of ground water of more than 4 metres has been observed in certain pockets in the States of Andhra Pradesh, Gujarat, Haryana, Karnataka, Madhya Pradesh, Maharashtra, Orissa, Punjab, Rajasthan, Tamil Nadu, Uttar Pradesh and West Bengal. The decline in the ground water level in some parts of the country is attributable to several natural and human factors like heavy withdrawals, exceeding replenishment, excessive run off and variation in rainfall etc.

(b) In Punjab, decline of 4 to 5 metres in the levels of ground water has been observed in parts of districts of Amritsar, Firozpur, Jalandhar, Ludhiana, Patiala, Roper and Sangrur.

(c) Certain measures like artificial recharge of ground water through instruction of check dams, percolation tanks as well as changes in cropping pattern are in vogue in various States including Punjab to improve ground water level.

#### **Vacation of Kangla Fort, Imphal by Assam Rifles**

(a) whether a portion of the Assam Rifles Battalion has been moved out of the Kangla Fort by March 31, 1996 as has been assured by Government; and

(b) if so, the details thereof and the steps taken for shifting of the remaining portion at the earliest?
