THE MINISTER OF HOME AFFAIRS (SHRI INDRAJIT GUPTA):

- (a) The UN-Convention against Torture has not yet been adopted by India and some other developing countries.
- (b) This issue was discussed in the Chief Ministers' Conference held on 5th May, 1995. Most of the Chief Ministers were either not infavour of India becoming a signatory to the Convention or were in favour with reservation on certain clauses the Convention.
 - (c) Yes, Sir.

Artificial Recharge of Ground Water

*292. SHRI SURINDER KUMAR SINGLA:

DR. SHRIKANT RAMCHANDRA JICHKAR:

Will the Minister of WATER RESOURCES be pleased to state:

- (a) whether Government prepared and published the 'Manual of Artificial recharge of ground water';
- (b) if so, when and how many copies of the Manual have been sold:
- (c) to what extent recharge has been effective after the Manual came into vogue; and
- (d) Government's plans for effective ground water recharge?

OF THE MINISTER WATER **JANESHWAR** RESOURCES (SHRI MISHRA): (a) Yes, Sir.

- (b) It is not a priced publication. One thousand copies of Manual had been printed in 1994 out of which 350 copies have been circulated for use, mostly among State and Central Government agencies.
- (c) Manual only provides guideline in the formulation of recharge schemes.
- (d) A Central Sector Scheme of model studies in Recharge of Ground Water prepared by Central Ground Water Board is under implementation. Besides,

a Centrally Sponsored scheme to assist states in recharging Ground Water is at consultation stage with concerned agencies.

Waiting List of Telephones in Delhi

THE MINISTER OF COMMUNICATIONS (SHRI BENI PRASAD VERMA) (a) The number of persons on the waiting list for new telephone connections as on 1st July, 1996 is 51,165.

- (b) Progressive reduction occurs with addition of more capacity.
- (c) It is planned to provided in Delhi 2,50,000 telephone connections during 1996-97. Telephone connections in Delhi may become available on demand by 1997 except in some areas due to technical nonfeasibility.

Loss Suffered by Cochin Shipyard

- *295. SHRI O. RAJAGOPAL: Will the Minister of SURFACE TRANSPORT be pleased to state:
- (a) whether it is a fact that Cochin Shipyard had approved a proposal to enter into a contract with M/s. ABB, Sweden in November, 1993, to revamp 150 T Gantry Crane which was subsequently cancelled;
- (b) if so, the reasons therefor and the contractual amount approved in that regard;
- (c) whether it is also a fact that the Cochin Shipyard re-tendered the contract and entered into a contract with M/s ABB, Sweden for revamping of 150 T Gantry Crane;
- (d) if so, the reasons therefor and the contractual amount settled for this contract; and
- (e) whether there has been any loss suffered by the Cochin Shipyard in this process; if so, the amount thereof?

- THE MINISTER OF SURFACE TRANSPORT (SHRI T.G. VENKATRAMAN): (a) No, Sir.
 - (b) Does not arise.
- (c) and (d): No, Sir. The Cohin Shipyard Ltd. did not re-tender the contract nor did it enter into any contract with M/s ABB, Sweden. However, as the 150 T Gantry Crane installed in the Shipyard in 1979 required replacement of its control system, open tenders were invited and order placed on M/s ABB, India after following the laid down tendering procedure. The contract was placed for Rs. 105 lakhs.
- (e) No, Sir. There has been no loss on this contract.
