SHRI MATANG SINH: Madam, the reasons for the delay are: some cases are still under the consideration of the Government. Information is to be collected from various State Governments, Union Territories and public enterprises. The Ministries are being requested to expedite these cases for implementation of these assurances.

Therefore, it should be understood that only in special circumstances, where there are unavoidable delays, we go to the Assurances Committee and ask for extension of time. That is why. In some cases, there is delay. Sometimes, information does not come from the State Governments. In some cases, the assurance is not completely fulfilled: there is part fulfilment of the assur-

THE DEPUTY CHAIRMAN: It is quite possible that the State Governments might have changed.

SHRIMATI MARGARET ALVA: They do not give even information.

THE DEPUTY CHAIRMAN: They might not be co-operating. That is why they might not have given it.
