

REPORT OF THE DEPARTMENT-RELATED PARLIAMENTARY STANDING COMMITTEE ON SCIENCE AND TECHNOLOGY ENVIRONMENT AND FORESTS

SYED SIBTEY RAZI (Uttar Pra. desh): I present the Sixteenth Report (In English and Hindi) of the Department-related Parliamentary Standing Committee on Science and Technology, Environment and Forests on the Annual Report (1993-94) of the Ministry of Environment and Forests (Environmental Pollution and Related Issues).

SHRI MD. SALIM (West Bengal): You cannot bulldoze the House like this.
