SHRI S. B. CHAVAN: We have to naintain that. If Mr. Jaipal Reddy and thers would like to put on record that if did not mean that they were going to concede this or that, if we were also to vay something, this would only raise some kind of a controversy again which, in fact, we were trying to avoid. Therefore, I would request all of you. I have 10 objection to giving time for consultaion, whatever time is required for consultation. Immediately, the consultation should start. Thereafter, if there is an understanding between the Government and the leaders of the Opposition it could be brought forward. At the same time, you should not say that it does not mean that you would concede something. This kind of a thing should not be said. Everybody should sit together and discuss it with an open mind and try to help the Government for projecting correct image of the country in the international community,

this. Kindly do not raise all kinds of issues at this stage. Let us discuss it and if there is any point on which some information is required, the Government would be very happy to supply that information. At the same time, we are also equally interested in getting the co-operation of the opposition in getting this Bill passed.

THE DEPUTY CHAIRMAN The matter is over.

SHRI G. G. SWELL (Meghalaya); Madam, I want to say omething (Interruptions)
