We have religious communities, minorities, etc. They have the right to have their own religious rights to be imitated. Some other minorities are here, their rights also are to be protected and the State Government or the Central Government should go by the rule of law. Shri Bal Thackeray's order for the elimination of the whole population coming from Kerala should be carried out by the police and not by the Shiv Sainiks. If this is the way a man goes about ordering, things will go out of hand, things will be in disorder things will go out of law. The law by which he has come to power is being violated by his Government. I am worried about the statement made by the Chief Minister. The Chief Minister of Maharashtra said, "I will read with pride the statement made by Mr. Bal Thackeray". What does it mean? That means, the Chief Minister is allowing the Shiv Sainiks to go and deal with the Bengalis. And if it is a question of dealing with those people who have come with a correct passport, what is the mechanism to operate? The Government machinery should be there to operate and not the Shiv Sainiks. No Shiv Sena leader should order that they should be attacked or killed. There must be a Government machinery. That is the legal forum. I am very glad the Home Minister is here. I want the Home Minister to tell us what they will do in a situation that has arisen in Maharashtra wherein legal positions are being publicly violated by the Chief Minister himself. This situation has arisen. The Government of India has to think over how they will deal with such a situation. India is a multi-national country wherein, you and I, Sir, can go and stay anywhere.

AN HON. MEMBER: Sir, you continue after lunch.

THE VICE-CHAIRMAN (SHRI V. NARAYANASAMY): Just a minute. If the House so agrees, we will dispense with the lunch hour and continue with the discussion. ... (Interruptions). ... It is

**RE: RESENTMENT OVER
STATEMENT MADE BY THE SHIV
SENA CHIEF—contd.**

SHRI VAYALAR RAVI (Kerala): Madam, the House is almost unanimously expressing its anguish and concern about the statement by Mr. Bal Thackeray, the boss of the Shiv Sena, which is part and parcel of the Government in Maharashtra. And I am more concerned about the statement of the Chief Minister himself.

Madam, my sympathies go to Mr. Sikander Bakht, the BJP leader, who tried to justify Mr. Bal Thackeray's statement and the support extended to it by the Chief Minister. Madam, Mr. Sikander Bakht was reading out the statement of the Chief Minister, and I want to read out the sentence next to the one where he stopped. There the Chief Minister says, "I shall be guided by them wherever necessary." What does it mean? It means, guided by the directions of Mr. Bal Thackeray. And he is not stopping there. Since everybody has expressed their opinion on the question of their alliance I do not want to go into the details. Then, the Chief Minister says, further, about the role of the Sainiks: "The role of the Sainiks would be merely to identify foreigners, to give information. The police would take action by initiating due process of law." I do not know when the Shiv Sainiks had taken the law into their hands. Even the Chief Minister has admitted that the Sainiks are going to every house of the minority community, knocking at their doors and asking, "Are you a foreigner or not?" And they are asking the police to take action. That means a new Sainik Administration. It is not a combination of the BJP and Shiv Sena but a mere Sainik Administration and a Sainik Government in the sense that a Sainik rule has come into existence in the city of Bombay. This is
